MINUTES OF THE **WRAXALL & FAILAND PARISH COUNCIL** MEETING HELD ON 11 JUNE 2013 AT THE CROSS TREE CENTRE, WRAXALL

DECLARATION OF INTEREST – Cllr. Hugh Pratt - 141e.

ELECTION OF A VICE CHAIRMAN – Cllr. Ambrose was proposed by Cllr. Law and Seconded by Cllr. Sage. Cllr. Ambrose accepted the proposal and signed the Acceptance of Office form.

138 MINUTES OF THE ANNUAL PARISH MEETING HELD 7.5.13 & THE ANNUAL GENERAL MEETING HELD 14.5.13 were agreed and signed.

139 CRIME FIGURES – Theft from Motor Vehicles – Car Park Ashton Hill Woods - £450 drill stolen.

Theft from Battle Axes – I Pad, belonging to member of staff, stolen.

Theft from Budgens - £200 meat stolen.

(Two burglaries in Long Ashton – non dwelling – were mentioned)

Speedwatch – Failand. Training has been done, now they need equipment. £150 to come from NSC for Speed Gun and Tabards. PCSO was asked what offenders received –

First offence – Written warning from Police

Second Offence - Another letter.

Third offence – Visit from the Police.

Visit from Police if the offenders are officious to the volunteers.

140 QUERIES TO THE LIAISON OFFICER – NIL. D/Cllr. Cave asked for explanatory e-mail regarding P/A's being rec'd 'As and When' rather than weekly as in the past. This new arrangement often results in Cllrs. visiting the site, and neighbours, before the neighbours have been advised that a P/A has been submitted.

Cllr. King had said that he had not been notified of P/A's – 2 on Chantry Mews, 1 on St Bartholomew's Church. He felt that, as a land owner, he should have been notified. He maintained that notices had not even been put up on posts or walls at those sites although the P/O said that this had been done in each case.

141 ISSUES

a GE Oil & Gas – Cllr. Ambrose had drafted a letter to be sent to David Turner regarding the P/A, which is temporary, when the temporary period is up. He proposed this should be sent to David Turner. Seconded by Cllr. Delmas. Voting Unanimous.

b PYLONS – Cllr. Pratt reported – NG had put 10% in the Business Plan for under grounding. If all was to be under grounded it would be 3 times the cost of over grounding. It has taken 4 years for NG to realise that they are not correct – They can't transmit the power they say on the plan they had. Dr Neumann is reassuring – he is a super authority. His report has been circulated to Cllrs. Cllr. Robinson to send an e-mail to Cllr. Pratt re the report critique. We will see the document before it goes to NG. Cllr. Sage said that he had read the report and Dr Neumann seems to say that most of the cabling will go over-ground. NG are not considering the 'blight'. He felt that a covering letter should beincluded with the report.

Dr Neumann has more costs – we have agreed an amount. Allow £10000. Cllr. Ambrose felt that the value of the works seems more like £20000. Cllr. Pratt thought more like £15000. Cllr. Robinson was concerned as to whether the cost should be borne by just this Parish. He realised that Nailsea had contributed previously but asked if we have any plans to recoup from other parishes. Cllr. Thompson said he was unhappy that we were bearing the cost when we are not as affected as other PCs. It was explained that when it was first mooted the line could have been through Wraxall and so we did the referendum to raise funds to work against it. Cllr. Sage said that he was keen to get other PCs to contribute. Cllr. Ambrose explained that most PCs on the route don't have a vast amount – say £200. Cllr. Pratt proposed that he and Cllr. Ambrose agree with Dr Neumann the amount of extra work he had done over the agreed amount. The cost to be e-mailed to all so they come to the next PC to vote. Cllr. Ambrose agreed with Cllr. Delmas that we should keep Dr Neumann 'on our side'.

- c COMMUNITY RESILISENCE Due to our APM and tonight's PC meeting, Cllr. Law has missed the last two workshops. Ian Wilson (NSC Emergency Manager) is putting some figures together re. vulnerable persons. Hannah Cornock (Emergencies Dept. NSC) asked to give a detailed resume of tonight's workshop.
 - d ELECTORAL REVIEW Response sent to Daniel Knagg 28.5.13.
- e TYNTESFIELD SPRINGS a set of questions had been sent to Clirs. They are to be sent to various Departments/Authorities asking for their answers. Proposed by Clir. Ambrose that this should be done. Seconded by Clir. Sage. Voting Unanimous.

142 PLANNING & DEVELOPMENT

a APPLICATION - 13/P/0828/F – Realignment of existing drive and creation of a new vehicular access for Adam Brown, Chantry Mews, Sandy Lane, Lower Failand.

RECOMMENDATION -Having read the arboricultural report, inspected the trees in question and discussed with the applicant and neighbours we believe that this application is acceptable.

We ask that the N.Som. Tree Officer visit the site to approve the arboriculturalist's report and recommendation; and that replacement trees will be planted on site as per 5.9.1. in his report.

We wish to point out that mains water supply and underground telecom cables are extremely close to the proposed position of the new gateway.

There was no objection to the new gateway altering the 'street scene'. APPROVE.

- b MILLENNIUM GREEN Asked Landscape Services to remove brambles. It has been brought to our attention that the padlock on the outer gate is corroded and cannot be used to lock the gate. Consequently people have been driving into the first area and taking picnic tables etc into the Play Area. As the first area contains a foot path it was felt that it was dangerous to leave the gate unlocked. A new padlock has been bought and Landscape Services, who deal with our Grass Maintenance, are to bolt crop the old padlock off the gate and use the new padlock, which we have supplied, to lock the gate shut. They have a key for access.
