**ELECTION OF A CHAIRMAN** – Cllr. Robinson was proposed by Cllr. Law, seconded by Cllr. King. There being no other nominations, and Cllr. Robinson stating that he was willing to continue as Chair, a vote was taken and Cllr. Robinson was elected unanimously.

**ELECTION OF A VICE CHAIRMAN** – This was deferred until the next meeting but if not then decided it was not to go on vacant after 2 meetings.

**DECLARATIONS OF INTEREST** – Cllr. King 132b, Cllr. Sage 132b & Cllr. Pratt 131a.

- **128 THE MINUTES** of the last meeting were agreed and signed.
- **CRIME FIGURES** PCSO ROBBIE introduced himself and reported the following crimes which had been reported to the Police since the last meeting:-

Two thefts from unsecure areas – Clevedon Road & NS Showground.

One dwelling burglary – Tiles from roof in Weston Road, Failand.

Two non-dwelling burglaries.

Cllrs. Sage & King queried an incident at Ridge House where wire cutters were used on the fence. It is thought that the house had been accessed from the Water Tower. Also the house next door a few days before. Oil had been taken in other areas.

Cllr. King mentioned a serious accident – a 4 car collision at the Down's School entrance. A first car did not see one turning in. It left an oil leak on the road. PCSO said that it was not 'serious'.

Cllr. Law (& Cllr. Delmas) had been to visit the site. They had taken photographs and made notes. Cllr. Law gave a resume of the visit.

Cllr. Robinson said that we have ascertained that there are no contraventions but some concerns.

It was said by Cllrs, supported by D/Cllr. Cook that we should pass the concerns to NSC. Cllr. Pratt asked to speak and advised that the possible flooding issue had been looked at by NSC and an outside agency — Drainage Board.

Cllr. Sheppard proposed that the meeting should be closed so that any further questions of clarification could be asked of the neighbours. Seconded by Cllr. Law. All in favour.

## MEETING OPENED 8.15pm.

The Parish Council cannot comment on anything except a Planning Application.

Concerns will be put to NSC.

- b DISPENSATIONS This had been dealt with at an earlier meeting.
- c STANDING ORDERS The NALC standing orders were being looked at with a view to using the relevant ones for this PC. Cllr. Ambrose will draft a proposed amendment.

No 30 to be used as a standard clause when we go to tender..

Code of Conduct – refer to Monitoring Committee.

Form a separate committee (say 3) at the time of a breach.

All content and in favour.

d GE OIL & GAS – Cllr. Sheppard said that there were 'No special Circumstances' in this case and that it had been badly handled.

Licence for car parking spaces on the old Coates Cider factory has been allowed to lapse by GE. Cllr Elfin Ap Rees has met with GE & JRW Properties (owners of the cider factory space). Both parties have agreed to relicense the car park space but need a purchasing order first. Hopefully cars will be parking in Coates again soon, relieving the on road parking.

Cllr. Ambrose has sent a letter to Dr Fox MP with a copy to Richard Kent, D/Cllrs. Cook and Cave. The letter to be sent to all Cllrs.

D/Cllr. Cook said that GE have said they are bringing in more staff.

Clerk to ask Richard Kent what happens after 5 years. (post meeting note – Richard Kent said that 'The car park will have to be removed unless a planning application to retain it is submitted and approved').

- e PYLONS Clerk to circulate the note, Cllr. Ambrose did for the APM, to all Cllrs. D/Cllr. Cook said that Dr Fox is saying that NG should take more notice of the environment.
- f COMMUNITY RESILIENCE Cllr. Law asked that 'What if' posters be put on Notice Boards. Cllr. Law intends to go through the e- learning. He and Cllr. Delmas are updating the Emergency Plan for Wraxall and Cllr. Thompson with Cllr. Sage (in place of Cllr. Mrs Shaw) will update the Emergency Plan for Failand.
- g NEIGHBOURHOOD PLANS Cllrs. Sheppard, Robinson & Mrs Moon are looking at the NHP interacting with Long Ashton. Cllr. Ambrose said that should the Core Strategy not be accepted, we want to stay green. NHP could just state that.

  Cllr. Sheppard said we could just state the status quo, rather than doing another big project like the Parish Plan. He felt we should just observe what is going on elsewhere.

  Cllr. Sheppard will have another meeting when Cllr. Mrs Moon returns from her holiday.
- h ELECTORAL REVIEW. Cllr. Sheppard thought that NSC may go to single member wards. D/Cllr. Cook thinks that 2 members will stay for Wraxall & Long Ashton. Leigh Woods could be taken into our 'group'. Cllr. Robinson tabled a proposed response together with Cllr. Ambrose's amendments at the meeting and Cllrs. agreed to this plus proposals made at the meeting. I agreed to circulate a final draft. sending Cllr. Robinsons' submission.
