MINUTES OF THE **WRAXALL AND FAILAND PARISH COUNCIL** MEETING HELD ON 13 JANUARY 2015 AT 7.30PM in Failand Village Hall.

DECLARATIONS OF INTEREST – Nil.

- 1 MINUTES The Minutes of the meeting held 9 December 2014 were agreed by 10 Cllrs. and signed, with one Councillor voting against.
- 2 CRIME FIGURES PC Peter Rooke introduced himself to the meeting (having taken over from PC Matt. Christie). He has worked in the area for some time so knows it well. He is keen to register and mark pushbikes as they are being targeted in and around this area. He has marked 600 already. Crime figures for the last month Only 1 Burglary in Church Lane, Lower Failand but he warned that Shed burglaries are happening again. Residents should be vigilant in securing their property.

3 ISSUES

- a ALLOTMENTS Cllr. Robinson had received a call from Mr Hugh Vowles who stated that he may have a piece of land suitable for allotments.
- b PYLONS There is to be a 'Pre meeting' in WSM on Monday next we have already sent our response but Cllr. Ambrose will attend with Alison Lock (Solicitor) & Cllr. Hugh Pratt, as a High Voltage Cable expert in his own right. Representatives from some other PC's on the Pylon route are attending. A representative of the residents of Cadbury Camp Lane has also sent in a response. Dr Liam Fox M.P. cannot attend.
- c GE OIL & GAS NOISE & PRIVACY ISSUES We are waiting for a reply from NSC.
- d SPEEDWATCH Long Ashton has offered, and we have accepted the loan of their VAS. Nigel Bain of Failand Speedwatch will report back as to whether the VAS from Long Ashton is suitable for their needs once they have completed the trial.
- e PICNIC TABLE. Chairman, Cllrs. King & Delmas & the clerk are to decide which table is to be purchased bearing in mind that it must have wheelchair access. Nailsea Community Trust, Wraxall Parochial Charities & the Parish Council have each pledged £500.
- f STANDING ORDERS Deferred to February meeting.

7 MEETINGS

a LIDL – There are 5 pages of details on the NSC Web site. The consultation ends on 19 January which is before the Public Meeting on 25th. Most objections are re parking spaces. The shop vacancy rate in Nailsea is high now and this could be exacerbated if people can't find anywhere to park. Disabled spaces are reduced which will impact on those with limited mobility wishing to attend the surgery.

MEETING CLOSED 8.14PM

Mr Simon Beck addressed the Council. He mentioned that the population of Nailsea is likely to rise as there are 450 sites identified around Nailsea for housing. Parking is already difficult at times now.

MEETING REOPENED 8.17PM

Restricted times for deliveries should be included in the conditions if the P/A is approved. Chairman & Cllr. Sage will attend the Public meeting.

4 PLANNING & ENVIRONMENT

a APPLICATION 14/P/2627/f - Variation of conditions no. 5 & 6 of planning permission 14/P/0110/F (Formation of a soil planting base to enable the reversion of Racecourse Quarry back to woodland) to state that all material will be inert and quantities and qualities of material shall be in accordance with the recovery operation as approved by the Environment Agency reference EPR/BB3903MN and specified in the relevant Racecourse Quarry Recovery Plan Version 1.2. and the relevant Environmental Permit for Mr M Aitkens, Limekiln House, Portbury Lane.

RECOMMENDATION – Approved unanimously. This will be an environmentally friendly and most suitable use for the quarry. It will mean that its safety will be improved, and dissuade people from using the area as a traveller encampment or for fly-tipping.

b APPLICATION 14/P/2661/PDA – Prior notification for erection of an agricultural building and the construction of an access track for NSAS on Land to East of Bathing Pond Wood (north-west of Mill Farm), Off Bristol Road, Flax Bourton/Wraxall & Failand.

This application has been determined by NSC – Prior approval is required and is REFUSED. Bathing Pond is Grade II & Bathing Pond Wood is a Registered Historic Park & Garden. The track and Building would harm the setting of Historic Assets contrary to Section 12 NPPF, Policy CSS of NS Core Strategy & Policies EHC/4 & EHC/5 of NS Replacement Local Plan.

c APPLICATION 14/P/2734/CUPA – Prior approval for the change of use from agricultural building and land to a single dwelling within use class C3 (No operational development) for Ms Hewitt re Land at Weston Hill Farm, Weston Road, Failand (Long Ashton P/A for comment).

This has always been known as ASHTON Hill Farm. The barn is isolated and in the Green Belt. It is misleading to describe Weston Road as having a wide pavement and this proposal as being consistent with the other side of the road. Residents of the area overlooking the barn have objections. 14/P/2734/CUPA (22/12/14) & PREVIOUS APPLICATION 14/P/0981/CUPA.

Further to the comments made by this council re: P/A 0981, we have new comments following the P/A 2734.

RECOMMENDATION – NOT TO SUPPORT

It appears that a significant amount of demolition and rebuild would have to take place to alter this barn into a residential dwelling. Although the barn has a partial concrete base, we believe that new footings and floorings would have to be inserted. This would virtually constitute a new build, which is non-permitted development in the green belt.

The barn is isolated from the actual farm buildings, which are at least two fields away.

The current application appears to be supported by applications for conversion of Dutch barns, allowed on Appeal, at Bartlett's Farm in Hampshire and at Pope's Farm in Dorset, and also by N-Somerset decision on Myrtle Farm at Regil. They are not comparable to this application, as they are in close proximity to their associated farmhouses and other farm buildings, and the issue of the Green Belt is not mentioned.

- d APPLICATION 14/P/2748/NMA Non material amendment to planning permission 11/P/1245/F (Change of use and alteration to 2 no traditional stone agricultural buildings to create 3 no dwellings and 3 no work units together with associated landscaping works including the reinstatement of a walled garden. Removal of units E,F and G and restriction on units H, J and K to ensure use for non-livestock agricultural purposes) to allow alterations to internal layout, of dwelling (Unit B), replacement of door with window to Bedroom 2 and replacement of window with door to utility room for Ms C Wyatt, Birdcombe Farm, Tower House Lane, Wraxall.
- e APPLICATION 14/P/2749/LB Alterations to internal layout of dwelling (Unit B), replacement of

door with window to Bedroom 2 and replacement of window with door to utility room for Ms C Wyatt, Birdcombe Farm, Tower House Lane, Wraxall. RECOMMENDATION for d & e- Deferred to February meeting.

- f APPLICATION 14/P/2699/F Erection of a food store with associated car parking for Lidl UK at Car Park at Crown Glass Shopping Centre, Stock Way South, Nailsea. SEE ABOVE ON PAGE 1.

14/P/2372/LB – The Hayloft, Stable Yard, Tyntesfield – Removal of mortar fillet and replacement with lead flashing to correct persistent water ingress and decay to timber roof framing and stairs. CONSENT GRANTED

14/P/2381/LB – Building adjoining Home Farm Estate Yard, Tyntesfield – Extension of roof to existing Bin Store to west of Home Farm complex to provide cover for existing goods lift. CONSENT GRANTED

14/P/2403/TPO-19 Bowden Way, Failand -3 x Oak Trees. Branch reduction in length by 3m. GRANTED.

14/P/2486/TPO – 3 The Willows, Manor Way, Failand – T1 Silver Birch – Fell and replace with Silver Birch. T2 Oak – Fell and replace with Oak. GRANTED

We still require to know exactly where the location of the path is being proposed.
